Twitter Retweet function caused moral rights infringement in Japan - June 30, 2018

The Japanese Intellectual Property High Court ruled that tweeting a photo without the permission of the photographer is considered to represent a copyright infringement. In addition, the IP High Court judges declared that, in this case, the process of the Twitter Retweet function caused moral rights infringement.

Japan to consider expanding design protection - June 23, 2018

From the perspective of increasing Japanese companies' competitiveness, Japan has suggested to amend its design law in order to cover a larger design spectrum. As development of technologies and design protection are closely intertwined, the Japanese government raised the idea of expanding the protection of designs to both projection designs and spatial designs. Further considerations include extending the duration of design rights and allowing a single design application filing for more than one design.

Women's participation creates high-value patents - July 27, 2018

The Development Bank of Japan published a report on July 16th 2018, showing that companies would create higher economic value patents if both male and female inventors participated. The study showed that the economic value of a patent which was jointly invented by male and female inventors is 1.5 times the value of a patent which was invented by a single male inventor. Additionally, the Research Institute of Economy, Trade and Industry displays in a report that companies which have a higher percentage of female researchers file more patent applications from a greater variety of fields.

Female participation in the Japanese labor force not only alleviates the aging population problem, but also appears to strengthen economic growth by promoting innovations both quantitatively and qualitatively.

Japan's Giant Telecom Provider Files for Patent to Use Blockchain for Contracts Storage - July 24, 2018

A recent Nippon Telegraph and Telephone's (NTT) patent application suggests that the Japanese Telecommunication company may seek to create new types of contract agreements relying on blockchain technology. This new system is believed to simplify contract agreements by using encryption and information decentralization. NTT's idea is to use a blockchain as evidence of a

contract made along a plurality of parties. The influence of blockchain is increasing in Intellectual Property law with major companies acquiring patents for innovations relying on this system, such as Master Card and Boeing among many others.

<u>Asia's first patent arbitration hub to open in Tokyo and JPO – Intellectual Property Arbitration</u> <u>Portal Site – June 28 and July 9, 2018</u>

Asia's first International Intellectual Property specialized Arbitration body is set to open in Tokyo next month. The International Arbitration Center in Tokyo ("IACT") is to be distinguished from the already existing Japan IP Arbitration Center. The IACT will incorporate multiple local and foreign arbitrators, including a former US chief judge of the Court of Appeals for the Federal Circuit and a University of Tokyo professor. Ambitiously, it is anticipated that intellectual property disagreements will be solved within one year. The Japanese government hopes that the IACT will be capable of competing with thriving arbitral centers such as Hong Kong and Singapore. The IACT will enable IP related disputes between non-Japanese companies to be heard, if all parties agree. Furthermore, even though patents are registered separately in different countries, Tokyo's arbitral awards will be binding across all New York Convention signatories' countries.

The JPO has created a portal site for Intellectual Property Arbitration which will continue to be updated as matters progress.
