The Abe administration has announced its decision to appoint Naoko Munakata as the new JPO Commissioner. This is the first time a female has been appointed to the position of JPO Commissioner. Ms. Munakata assumed the position of secretary to the Prime Minister two years ago and originally cut her teeth at the Ministry of Economy, Trade, and Industry (METI). This decision is part of government efforts to promote gender equality while strengthening efforts regarding intellectual property (IP) to strengthen industrial competitiveness.

The JPO announced an action plan to use AI for operations at the JPO. The plan includes utilization of AI or feasible study of AI for:

- The call center / help desk,
- Electronic filing,
- Electronic study of applicants' stamps,
- Confirmation on whether registered trademarks are used in specifications,
- Quality checks of submitted documents (typographical error detection),
- Patent and design classifications,
- Prior art searches and prior design and trademark searches,
- Understanding and recognizing inventions, and

- Decisions on whether inventions are patentable, whether designs are registrable, and whether trademarks are registrable.
