Conference on Challenges to tackle antimicrobial resistance, **Thursday, April 5th, 2018**

In connection with our firm 20th anniversary celebration, we hosted Dr. Yoshiaki GU conference on April 5th, 2018 about 'Challenges to tackle antimicrobial resistance'. Dr. GU, from the National Center of Global Health, has exposed to us the stakes related to resistant bacteria and virus against medicine.

Indeed, from a medical point of view, it has been observed that bacteria have developed resistance to our available drugs due to mutations of their gene pool. Those genetic transformations allow them to adapt to hostile environment created by medicine.

Therefore it has been noticed that antibiotics are no longer effective on bacteria. We have for example observed such a phenomenon concerning influenza. How should we react to such resistance? The current response is to prescribe other medicine treatment or antibiotics however bacteria and viruses would definitively succeed in resisting those in the near future too.

Dr. GU explained how we reached such conclusion through pertinent medical, technological and sociologic explanations and has suggested several solutions that could be very useful in the future to prevent resistant bacteria such as increasing prevention, improving medical training, reducing pharmaceutical lobbying, and reducing generic drug and antibiotics usage.

Three initiatives were decided: Expand target regions of cooperation (from April 2018); Increase the budget amount (from April 2019); Expand cooperative efforts (from April 2018). Japan Patent Office Decides "TE' CON MIEL" (Tea With Honey) Is Distinctive In Relation To Tea: February 20th, 2018

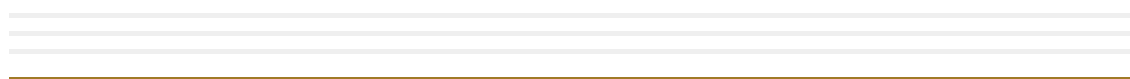
